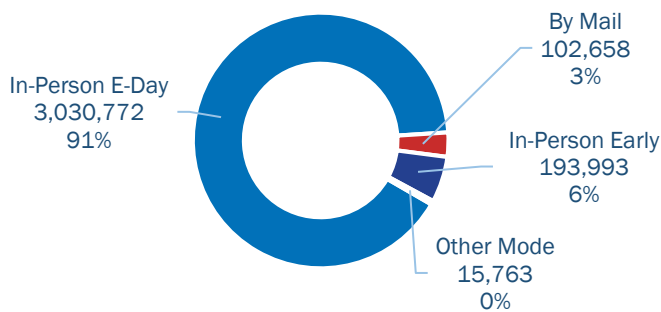

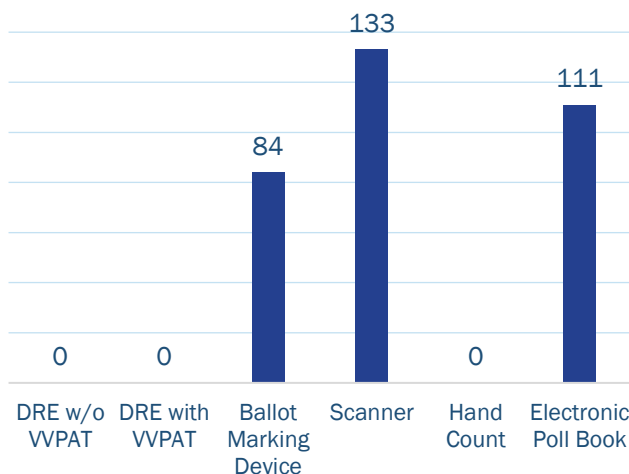
Voters Participating by Mode<sup>5</sup>

## + Election Policies

- ✓ Has online voter registration<sup>10</sup>

---

- Has a form of same-day voter registration (SDR)<sup>11</sup>

---

- Has all-mail elections statewide<sup>12</sup>

---

- Has all-mail elections in certain jurisdictions<sup>12</sup>

---

- Allows voters to register as permanent absentee voters<sup>13</sup>

---

- ✓ Requires excuse for by-mail voting<sup>14</sup>

---

- ✓ Requires excuse for in-person early or in-person absentee voting<sup>15</sup>

---

- Uses vote centers<sup>16</sup>
